No. 1: (i) A recognized medical qualification included in the First or the Second Schedule or Part-II of the Third Schedule (other than licentiate qualification) to the Indian Medical Council Act, 1956(102 of 1956). Holders of educational qualifications included in Part-II of the Third Schedule should also

fulfill the conditions stipulated in sub-section (3) of section 13 of the Indian Medical Council Act, 1956(102 of 1956). (ii) Post-graduate degree in the concerned speciality mentioned in Section –A of Schedule-VI or equivalent.

Essential Experience for Sl. No. 1: At least five years experience as Tutor/Demonstrator/ Senior Resident/Registrar/Lecturer in the concerned specialty in a recognized teaching Institution after the requisite post graduate degree qualification out of which at least 2 years shall be as Assistant Professor.

Essential Qualification For Sl. No. 2 to 4: (i) A recognized MBBS degree qualification included in the First or the Second Schedule or Part-II of the Third Schedule (other than licentiate qualification) to the Indian Medical Council Act, 1956(102 of 1956). Holders of educational qualifications included in Part-II of the Third Schedule should also fulfill the conditions specified in sub-section (3) of section 13 of the Indian Medical Council Act, 1956(102 of 1956). (ii) Post-graduate degree in the concerned speciality/super speciality/equivalent.

Essential Experience for Sl. No.2 to 4: At least 1 year experience for Pay level (L-11) / 3 years experience for Pay level (L-12) as Lecturer/Tutor/ Registrar/ Demonstrator/ Senior Resident/in the concerned Specialty or Super-speciality in a recognized teaching institution after obtaining the first post graduate degree.

Essential Qualification For Sl. No. 5 to 7: (i) I and II class (55%) in Masters Degree in Social Work/Psychiatric Nursing /Clinical Psychology. (ii) M. Phil in Psychiatric Social Work/Clinical Psychology or equivalent qualification from a recognized Institution. (iii) Ph.D in PSW/Clinical Psychology/Psychiatric Nursing from a recognized Institution/University.

Essential Experience for Sl. No. 5 to 7: No experience (for pay level L-10) Or At least one year teaching /clinical/research experience in the concerned subject after Ph.D. (for Pay level L-11) Or At least 3 years of teaching/clinical/research experience in the concerned subject after Ph.D. (for pay level L-12).

Note 1 :- Doctorate of Medicine (DM) or Magister Chirurgiae (M. Ch.) qualification of three years' duration shall be counted towards requirement of teaching experience.

Note 2 :- Doctorate of Medicine (D.M.) or Magister Chirurgiae (M.Ch.) qualification of five years' duration, shall be taken as three years for completion of post graduate and the two years of the said Doctorate of Medicine (D.M.) or Magister Chirurgiae (M.Ch.) shall be counted towards requirement of teaching experience.

Note 3: Teaching experience in any other post like the post of General Duty Medical Officer/Medical Officer shall not be considered for eligibility purpose for recruitment to teaching posts.

Abbreviation used: Unreserved (UR), Other Backward Classes (OBC), Schedule Caste (SC), Scheduled Tribe (ST), Person with Benchmark Disability (PwBD), S- sitting ,ST-standing, KC – Kneeling and crouching, MF- Manipulation with fingers ,SE- seeing, C- communication. Terms and conditions for all reserved categories including PwBD will be as per GOI norms.
