Sub: Filling up the post of Sub Inspector in Narcotics Control Bureau under Ministry Home Affairs on Deputation Basis.

Narcotics Control Bureau, Ministry of Home Affairs, intends to fill up **24 (Fourteen)** existing vacancies in the grade of Sub Inspector on deputation basis.
